Air Sentry is committed to minimising the adverse impacts of our business activities on the local and global environment, while meeting the needs of our customers. All Air Sentry employees are encouraged to act on their own to help protect the environment.

Air Sentry also expects its suppliers to have in place policies that promote environmental awareness, conservation, and sustainability.

As an organisation, we integrate the consideration of environmental concerns and impacts into our decision making and business activities. Externally, we promote sustainable consumption by developing and promoting environmentally sound technologies to support our customers' requirements. Internally, we will continue to develop, implement, and manage companywide environmental initiatives, including the following goals:

- Energy – Air Sentry plans to reduce its energy consumption per GBP revenue by 5% by June 30, 2025.
- Carbon – Air Sentry plans to reduce its scope 1 & 2 greenhouse gas emissions per GBP revenue by 5% by June 30, 2025.
- Waste – Air Sentry plans to work toward a goal of 65% diversion rate in our facilities by June 30, 2025.

As an industry leader, Air Sentry has both an obligation and an opportunity to take action that will improve the well-being of our customers, our planet and our society as a whole.
